Minutes of January 11, 2005

TREASURERS REPORT

Treasurer, Keith Arnold, reported the current balance for all NIFA accounts as \$7,632.87.

OLD BUSINESS

Ralph Eads asked the group if they were still willing to help financially support the purchase of a GPS unit for his office. Ralph stated that the Wild Turkey Federation pledged \$150.00 towards the purchase of the GPS. Questions were raised from the group as to how the GPS would be used and how much it would cost. Ralph explained the uses and said he would get a cost estimate for the next meeting. No further action was taken on this issue.

Dick Pouzar stated that the new Consumer Guide to Northwest Illinois Forest Products & Services is complete but he wants someone to proof read the Guide before publishing. Jerry Misek volunteered to do the proof reading.

NEW BUSINESS

Jerry Misek brought in a request from the Northern Illinois Land Use Council Envirothon Committee asking for financial assistance to help support the April 2005 Envirothon competition. The competition is open to high school teams in the 6 county area (same as NIFA boundaries). The teams compete in 5 subject areas, which are: soils, forestry, wildlife, aquatics, and environmental issues. Winning teams go on to state and international competition. In 2004, 35 high school teams from our 6 county area competed in the local Envirothon event.

After the group discussed the proposal, Dick Pouzar moved to provide \$100 for each county competing in the event from our 6 county area. Carol McPhillips seconded the motion. Motion passed.

Bill Hawes brought up the question of having lifetime dues for NIFA. Several suggestions were made. President Arnold asked that people with ideas should contact Keith Arnold or Bill Hawes. Keith and Bill will meet before the

February meeting to evaluate the ideas and bring them to the group.

Dick Pouzar asked if there are any more people who could receive NIFA information by email to lower mailing costs. Please contact President Arnold with your email address.

President Arnold called for a motion to end the business meeting and proceed on with the program for the night. Carol McPhillips so moved. Dick Pouzar seconded the motion. Motion carried. The business meeting was adjourned at 7:45 pm.

Tom and Janis Sleeter from the Financial Network presented a program on financial planning with emphasis on keeping forest tracts from being split up. Items covered included; timber valuations, income tax with emphasis on Form T, estate planning, gift taxes, insurance policies, and other assets.
